Opening Gates.

1. Any person who shall open or attempt to open any gates set up along the line of railway, with or without the intention of passing through the same, while a train is signalled or is in sight approaching, shall, for every such offence, forfeit a sum not exceeding ten pounds.

Signal Cord.

2. Any person who shall wilfully cut, pull, or otherwise interfere in any way with the signal cord which runs inside and underneath the roof of the railway carriages, unless in case of urgent necessity or danger, shall be liable to a penalty in any sum not exceeding ten pounds.
